Miles Carter, Gable Hall School

When you are running a high achieving and vibrant school which converted to academy status last July, you want a legal services provision you can rely on.

According to Miles Carter, finance director and business manager at Gable Hall School in Corringham, that is exactly what he receives from Palmers Solicitors.

This community role is further highlighted by Palmers involvement at career days at the school. For years, two or three members of their senior staff have taken the time to provide the students with mock interviews, with feedback provided to the students along with advice on techniques.

"Palmers takes the career day very seriously," says Mr Carter, "and the students find it invaluable. The days of work experience are over, so it is very important that students are not frightened by the interview process, especially when meeting professional employers."












With 1,265 pupils and a recently opened sixth form, Gable Hall School has quite a large site, with many of the legal issues surrounding property and neighbourhood matters.

"The big issues are boundaries, planning consents and neighbourhood concerns," says Mr Carter. "A lot of the matters are unusual, so avoiding the pitfalls when granting rights to the use of land is very important.

"We work with local charities, so it is vital that we receive advice from Palmers on how to do things for the charity's benefit and still maintain the school's rights and responsibilities.

"Palmers provides professional, clear advice to both the governors and myself as business manager. This ensures we recognise the legal position and protect public funds and assets.

Sue Newby, William de Ferrers School

South Woodham Ferrers-based William de Ferrers School achieved academy status in April 2011. Housed in a purposebuilt community complex, it has around 1980 pupils from Year 7 right up to sixth form, and shares certain facilities with other organisations.

As part of the complex, the school is committed to establishing ties with the local community and neighbouring primary schools, as well as including knowledge and awareness of the community within its curriculum.

According to Director of Services, Sue Newby, the school's relationship with Palmers fits in perfectly with this ethos.

"As Palmers is based in South Woodham Ferrers, it is a local company with an understanding of how the community works together and how we fit into that," she explains.

The long-standing relationship between William de Ferrers School

Sue Newby explained: "The firm has a real bank of knowledge about the school which it has built up over a long period of time and has developed an in-depth understanding of how we work."




